Hopes and Fears about a Sandy Mush Forest Restoration Coalition

Fears

- No Snacks!
- Not being able to sustain interest and drive long-term
- Long-term and widespread use of herbicides wildlife, landscape, watersheds
- Not being able to follow through

- How it will be paid for
- Grant money actually used for work on the ground with landowners
- Cost-share not possible for some landowners-still a cost

Hopes

- Get people that aren't here interested.
- Hearing from the community

Some Comments and Questions from coalition participants

- How severe is Japanese knotweed?
- What is the role of fire in controlling invasives and is it practical?
- Sandy Mush many years ago had way more pasture/agricultural land. These areas
 were eventually abandoned. Abandoned areas regrow as unmanaged forests that
 are perfect for invasives to move into.
- Interested in the difference in invasives. Species differences and treatment differences
- Oriental bittersweet is the perfect enemy. There is nothing you can do to it that it doesn't like. Breaking the root system brings it back. Need to have a plan of action, especially for this species.
- What is the federal government doing in Pisgah and Smokies and the extent of invasives in these areas?
- Federal Government needs a reward for people who help to control invasives due to the economic loses these species have created.
- Invasive Plant Medicine. May find that there is an economic purpose for these plants. Utilize these plants. Creates an incentive to harvest.
- Native wildlife does not get the right nutrition from these plants. Junkfood for wildlife. Lowers their immune system. Death of animals from invasives. Harms wildlife in many ways.
- There are people in the community that can teach and there are people that want to learn
